### **2008-2009 Financial Aid Application**

Thank you for applying for student financial aid at the College of Southern Nevada (CSN). All students planning to enroll at CSN for the 2008-2009 academic year must complete and sign the form on the back of this letter and return to Student Financial Services (SFS).

If you are required to submit additional application documents, an email, sent to your CSN student email address, will be sent by SFS. Please check your e-mail account regularly. To activate your account, log on to the [Student Web E-Mail Access](#) link located on the CSN homepage at [www.csn.edu](http://www.csn.edu).

If you **do not** complete and return the required documents, your file will remain in a pending status and no further action will be taken by CSN. After you have submitted all required forms and documents, SFS will determine if you are eligible for financial aid.

Students completing the application process for 2008-2009 will be considered for:

- Federal Pell Grant funds
- Academic Competitiveness Grant funds
- Federal Supplemental Educational Opportunity Grant funds
- Federal and State Work-Study Programs
- Scholarships
- State Grant funds
- Institutional Grant funds

If eligible, SFS will notify you by e-mail when a Financial Aid Offer Letter is available to view and print through the Online Registration link located on the CSN homepage.
