**Required Documents (two or more of the following documents);**

- Evidence of 12 months physical, continuous presence in the state of Nevada as the spouse's, parent's or legal guardian's permanent, primary residence at the date of matriculation (examples of evidence include home ownership, payroll stubs, utility bills). REQUIRED
- Copy of student's birth certificate, proof of legal guardianship, or spouse's marriage certificate or
- Copy of parent's/spouse tax return in the tax year of your matriculation (date you began classes) that you were claimed as a dependant.

**Submit 1 of the 3 items;**

- Copy of Nevada Drivers license or Nevada Identification card for parent, legal guardian, or spouse issued prior to date of matriculation.
- Copy of Nevada vehicle registration for parent, legal guardian, spouse's issued prior to matriculation.
- Copy of voter registration for parent, legal guardian, spouse's issued prior to matriculation.

\_\_\_\_\_ **Pathway 2 (student's residency - Requesting residency as an independent student):**

**Required Documents (one or more of the following documents);**

- Evidence of 12 months physical, continuous presence in the state of Nevada prior to the first day of instruction at the institution (examples of evidence include home ownership, payroll stubs, utility bills).

**REQUIRED**

Note: If under the age of 24: Copy of parent's tax return in the tax year of your matriculation that indicates that you were not claimed as a dependant.

**Submit 1 of the 4 items**

- Copy of student's tax return in the tax year of your matriculation that indicates a Nevada address.
- Copy of student's Nevada Drivers license or Nevada Identification card issued prior to date of matriculation.
- Copy of student's Nevada vehicle registration issued prior to matriculation.
- Copy of student's voter registration issued prior to matriculation.

\_\_\_\_\_ **Pathway 3 (Exceptions) Submit one or more of the following documents;**

- Active duty resident military - copy of military orders required
- Public school teachers employed full time or NSHE employee at least halftime - letter from employer required
- Nevada high school graduate - copy of diploma or transcript with graduation date required
- Native American who currently resides on tribal lands located wholly or partially within the boundaries of the State of
- Nevada. - copy of tribal card or blood document required
- Student's spouse, family or legal guardian has relocated to Nevada for the primary purpose of permanent full time employment or to establish a business in Nevada - letter from employer or copy of business license & NV driver's license or ID card required.
- Other exception as outlined in the Board of Regents policy. Appropriate documentation required.
