

Recent Workday Updates

Workday is highly configurable, allowing the institutions to make changes to the system as new priorities emerge and as requirements become better understood. The Workday team organizes this work into multi-week periods called Releases. Here are a few highlights from our most recent Release.

Expense Report for Candidates

You can now create expense reports on behalf of candidates who incur costs during the interview process. This eliminates the need for creating external committee members in order to reimburse candidates via expense reports. The Financial Administrative Assistant role can create expense reports for candidates by accessing the Create Expense Report for Non-Worker task.
