- 3. Proof of completion of all program requirements as listed on the Phlebotomy MLT/MLS Track Advisement Sheet.
- 4. Unofficial CSN transcript including final grade for CHEM 103, 110, or 121 and MATH 126 or MATH 126E or higher.
- 5. Unofficial copies of college/university transcripts listing completed Chemistry and Math courses with course description(s), if applicable.
- 6. Documentation of declared MLT or MLS major.
- 7. Unofficial copy of **one of the following**:

a) High School diploma, High School transcript, or GED equivalentb) College/University transcript with an AWARDED degree or copy of diploma

NOTE: CSN formal evaluation of transcripts from other colleges, including UNLV and NSU, is highly recommended. Contact the Office of the Registrar for the procedures. This process may take 10 weeks. Student is responsible for ensuring that the MyCSN Transfer Credit Report reflects accurate course(s) and grade(s). If formal evaluation is not completed, you must attach unofficial copies of all college/university transcripts with completed Chemistry and Math courses with course description(s).
