Program Description

The Health Information Technology Program (HIT) is designed for the working student. The majority of students continue to work full time jobs. The standard rule for study time is approximately 2 hours for every 1 credit hour. The program courses are generally offered online, in the late afternoon and evening with some weekends.

The Health Information Technology Program may transfer into a related Health Care Administrative or Baccalaureate Health Information Management Program depending on the receiving university.

Admission Requirements

The CSN Health Information Technology degree is a Limited Entry Program. Therefore, all prerequisite requirements must be completed by the completion deadline in order to be eligible for consideration. See reverse side for specific requirements.

Application Deadline

Students applying for the Fall 2020 program must submit an application to the Limited Entry Office by **June 1, 2020**. An application for admission may be obtained online at: <https://www.csn.edu/Limited-Entry-Admission>. Final grades or completed transcript evaluation must be in the Limited Entry Office by **June 1, 2020**. (Note: the transcript evaluation process may take up to 8-10 weeks, you must initiate this process at least 10 weeks before the completion deadline).

Accepted Students

Students accepted into the program will be required to show proof of health insurance and immunization against Hepatitis B, Measles, Mumps, Rubella, Varicella, Tetanus, and Diphtheria. In addition, proof of a negative two-step TB skin test and negative urine drug screen will be required prior to the first scheduled practicum/clinical experience. A physical exam is also required. Students may also be required to submit to an official background check. Medical insurance may be purchased through CSN Student Government.

Accreditation

The Associate Degree Health Information Technology Program at CSN is accredited by the Commission on Accreditation for Health Informatics and Information Management Education (CAHIIM).
